- AEC is a new step in Arctic Council's (AC) long-term work of sustainable business development in the Arctic
- AEC will be AC's preferred advisor in developing sustainable industry policies for the Arctic
- AEC will be uniquely positioned to influence the policies in the High North and the regulatory framework for business development
